Based upon the Company's and the group's economical position, the Board assess that the proposal for authorization for repurchase of own shares is justified, taken into consideration the nature, scope and risks that the operations imposes on the Company's and the group's equity, as well as the consolidation needs, liquidity and the overall position of the Company and the group.
